She will send us a picture to post to the website.

CWLP has received complaints of boats speeding past Marine Point. There are now 10 mi/hr signs posted. Be aware.

CWLP has purchased new buoys. Security has been busy relocating buoys that has been displaced over the past year. Call Mike Daley if you come across a buoy that has been displaced. He can be reached at 757-8600 X1003. The new buoys will have orange reflective tape place around the top to make them more visible at night. She asked if we would like to make a donation to help pay for the reflective tape. The US Coast Guard has approved using the use of the tape as long as it does not cover up any wording. The tape costs \$98 per roll. One roll of tape covers approximately 50 yards.

Courtney Ostrowski made a motion that SLSIA donate 3 rolls of reflective tape to CWLP and to make payment once the work has been completed. Peter Murphy provided a second. All voted in favor. Motion passes.
